- Fill the tank to correct volume with clean water pH of water must be between 6 and 7.
- Maintain agitation of spray mixture throughout application.

NOTE: Spray all surfaces in infested areas, internal structural surfaces, e.g., walls, roof/ceiling, infested furniture, mattresses, bedding, externally around doors, windows, inside and behind cupboards, under shelves, etc.
