## POTENTIAL HAZARD (DANGER)

• Highly toxic; may be fatal if inhaled; swallowed or absorbed through skin • Fire may produce irritating, corrosive and/or toxic gases.

## PERSONAL PROTECTIVE EQUIPMENT

• Protective goggles or face shield. • Protective gloves. • Protective shoes. • Eyewash bottle with clean water. • Respiratory safety device that will allow driver to escape. • Light protective clothing.

## DRIVER INTERVENTION EQUIPMENT

• Chemical protective clothing that is specially recommended by the manufacturer. • Dry chemical or CO2. • Shovel.

## DRIVER FIRST ACTIONS - Only if it can be carried out without personal risk

• Contact emergency services. • Stay upwind, uphill and/or upstream. • Stop the engine. • Avoid contact with spilled material.

## DRIVER SPECIAL/ADDITIONAL ACTIONS - Only if it can be carried out without personal risk

• Stop leak if you can do it without risk.

## DRIVER ACTIONS IN CASE OF FIRE - Only if it can be carried out without personal risk

• Large Fire - Move containers from fire area if you can do it without risk. • Small Fire - Dry chemical, CO2 or water spray.

## FIRST AID

• In case of contact with substance,; immediately flush skin or eyes with running water for at least 20 minutes. • Remove and isolate contaminated clothing and shoes. • Do not use mouth-to-mouth method if victim ingested or inhaled the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. • For minor skin contact; avoid spreading material to unaffected skin. • Move victim to fresh air. • Administer oxygen if breathing is difficult.
